



## INSTRUCTIONS FOR EXTENDED ABSTRACTS SUBMISSION

### GENERAL INFORMATION

EXTENDED ABSTRACTS related to the maize crop and advances of original works in progress with at less one year of information (that will be considered as COMMUNICATIONS) will be accepted until the 10 July 2018.

In the Congress website, in the "Descarga de Archivos" section, you will find the file "plantilla\_resumenes.docx", which you must use as the background for your work.

A scientific-technical committee will evaluate your work, may ask you for corrections or reject it in case it doesn't meet the standards. Once approved, the paper will be published in digital format and should be presented as a poster by the author during the congress.

### GUIDELINES FOR WORKS PRESENTATION

Extended abstracts and communications must have a minimum of 2 and a maximum of 4 pages, and must include an abstract with a maximum of 200 words. The extended abstract should describe an original scientific technical work and include, in a clear, objective and explicit way: importance of the topic, objectives, materials and methods, results, conclusions and references. Abstracts with the text: "The results will be discussed in the poster" will not be accepted. The text has to be sent in Word and PDF formats.

**Page configuration:** A4 paper size, margins: upper 2.5 cm, lower 2.5 cm, left 3.0 cm and right 3.0 cm.

**Title:** in CAPITAL letters, Verdana font, size 10, bold, starting from the upper left corner. Leave a blank line and then indicate the name of the authors.

**Authors names and affiliation(s):** The name of the author(s) should be written starting with the surname (first letter in capital letters) followed by the initial letters of the name(s) in capital letters, size 9 normal, starting from the left without indentation. The name of the co-authors should be separated by (;). The address, institution, city, province, country and email will be specified in the line below the author names using size 8.

**Abstract:** Following the name and address of the authors, leaving a blank line and starting from the left without leaving indentation, in a single paragraph, a summary with a maximum of 200 words will be presented, in size 9 normal style.

**Keywords:** Leaving a blank line, a maximum of five keywords will be included.



**Text:** The body of the text should be written using normal style, size 10, Verdana font, simple space. Paragraphs should have first line indentation in 1 cm and text written in simple spaced and complete justification. The tables and figures should be included in the text as an active part of the document in black and white. They will not be accepted in separated files. All the tables and figures must have titles and, at least, a reference in the text.

**Abbreviations:** The units of the international system and only conventional abbreviations should be used. Any initials or acronyms must be defined when mentioned for the first time.

**Financial support:** In case that any entity contributes with financial resources to the research project, it must be included at the end of the text before the bibliographic references.

**References:** References should be included when absolutely necessary, specifying the first author's surname and the year in the text, and, in the list of references under two forms: a) authors separated by (;) indicating surname followed by initials separated by (.), year, work title, abbreviated name of the publication, volume, initial and final page; or b) authors separated by (;) indicating last name followed by initials separated by (.), year, book title, publisher, city, country. Use normal style, size 8.

## SUBMISSION

During the registration process you have to generate the password that will allow you to access the abstracts submission system:

([http://congresodemaiz.com.ar/admin/form\\_resumenes.php](http://congresodemaiz.com.ar/admin/form_resumenes.php)). Each work must be named with the author's name and a correlative number if necessary (example: GONZALEZ\_HJ\_1). When submitting your work, you must select to which area it belongs:

- Bioeconomy (Bioeconomía)
- Genetics and plant breeding (Genética y mejoramiento genético vegetal)
- Crop management, fertility and uses (Manejo del cultivo, fertilidad y usos)
- Plant protection (Protección vegetal)

By sending the abstract or communication, at least one of the authors must have paid the registration fee. Each author with his registration may submit a maximum of two works.

## POSTERS PRESENTATION

The poster will be 80 cm wide and 120 cm high. The works will be exposed during the congress on a date and place specifically determined by the organizing committee.

Each poster will contain a reduced version of the work highlighting title, author(s), objectives, materials and methods, results and conclusions. If it is possible, the results will be presented with figures, graphics and/or photographs. The message must be clear enough to avoid its oral explanation. The poster must be readable at a distance of 2 m.



## The use of the following font sizes is recommended:

**Title:** not less than 2.5 cm.

**Name of the authors:** not less than 1.5 cm.

**General text:** between 0.7 cm and 1 cm.

**Pictures, figures, photographs:** 18 cm x 24 cm or larger.
